OUR COMMITMENT TO YOU

Falmouth Skeet Club is a nonprofit organization dedicated to the sport of clay shooting.

We collect only the information necessary to communicate with our members. We do not sell, share, or use your information for any marketing or commercial purpose.

1. WHO WE ARE

Falmouth Skeet Club ("the Club," "we," "us," or "our") is a nonprofit sports organization based in East Falmouth, Massachusetts, dedicated to the sport of clay target shooting. Our website is located at FalmouthSkeetClub.com.

This Privacy Policy explains how we collect, use, and protect information provided by our members, particularly in relation to our SMS text message communications program.

2. INFORMATION WE COLLECT

We collect only the minimum information necessary to communicate with our members:

- First and last name — to address members personally in communications
- Mobile phone number — to send SMS text message notifications and announcements
- Email address — for general club communications (optional)

This information is provided directly by members when they join the Club or voluntarily sign up to receive SMS communications.

3. HOW WE USE YOUR INFORMATION

Member information is used exclusively for Club-related communications, including:

- Event announcements, meeting reminders, and schedule changes
- Safety notices and range updates
- Club news, results, and member updates
- Administrative communications related to membership

We do not use your information for advertising, marketing, or any commercial purpose. Your name and phone number will never be used to promote products, services, or third-party offers of any kind.

4. SMS TEXT MESSAGE PROGRAM

The Club operates an SMS notification program to keep members informed about club activities and events. By providing your mobile phone number and consenting to receive text messages, you agree to receive SMS communications from Falmouth Skeet Club.

- Message frequency: Varies based on club activity — typically a few messages per month
- Message content: Club announcements, event reminders, and member notices only
- Carrier charges: Message and data rates may apply depending on your mobile plan
- Opt-out: You may opt out at any time by replying STOP to any message, or by contacting a club officer directly
- Help: Reply HELP to any message, or contact us at the address listed below

SMS messages are delivered using Twilio, a third-party messaging service. Twilio acts solely as a message delivery provider and does not use your information for any other purpose.

5. HOW WE PROTECT YOUR INFORMATION

Member contact information is stored in a secured membership file accessible only to authorized club officers. We take reasonable precautions to protect your data from unauthorized access, including:

- Access is limited to designated club officers only
- Member data is not stored in public-facing systems or cloud services open to third parties

- Physical and digital records are kept secure and reviewed periodically

6. WE DO NOT SHARE YOUR INFORMATION

Falmouth Skeet Club does not sell, rent, trade, or share member information with any third party — including advertisers, marketers, data brokers, sponsors, or affiliate organizations — for any purpose.

The only exception is our SMS delivery provider (Twilio), which receives your phone number solely for the technical purpose of delivering messages you have consented to receive. Twilio does not use this information for marketing or any other purpose.

We will not disclose your information to any other party unless required to do so by law.

7. YOUR RIGHTS

As a member, you have the right to:

- Request a copy of the information we hold about you
- Request correction of any inaccurate information
- Request removal of your information from our records
- Opt out of SMS communications at any time by replying STOP

To exercise any of these rights, please contact a club officer using the information below.

8. CHANGES TO THIS POLICY

We may update this Privacy Policy from time to time to reflect changes in our practices or applicable law. When we do, we will update the "Last Updated" date at the top of this page. We encourage members to review this policy periodically.
