1. PROGRAM NAME & DESCRIPTION

Program Name: Falmouth Skeet Club SMS Notifications

Falmouth Skeet Club ("the Club") operates an SMS text message notification program to keep members informed about club activities, events, and announcements. Messages are sent to members who have voluntarily provided their mobile phone number and consented to receive SMS communications from the Club.

This program is operated by Falmouth Skeet Club, a nonprofit organization located in Falmouth, Massachusetts (FalmouthSkeetClub.com).

2. TYPES OF MESSAGES

Messages sent through this program may include:

- Event announcements and schedule updates

- Meeting reminders and range availability notices
- Safety notices and important club updates
- Competition results and member news
- Administrative notices related to Club membership

All messages are Club-related only. We do not send advertising, promotional offers, or third-party marketing of any kind.

3. MESSAGE FREQUENCY

Message frequency varies based on Club activity. Members can typically expect to receive a few messages per month. During periods of increased club activity — such as competition season — the frequency may be slightly higher. We will not send unnecessary or excessive messages.

4. MESSAGE & DATA RATES

Message and data rates may apply. Charges are based on your individual mobile carrier plan and rate schedule. Falmouth Skeet Club does not charge any fee for this SMS program. Please contact your mobile carrier if you have questions about messaging rates associated with your plan.

5. HOW TO OPT OUT (STOP)

You may cancel your SMS subscription and opt out of all future messages at any time.

To opt out, reply STOP to any message you receive from us.

After sending STOP, you will receive one final confirmation message and no further messages will be sent to your number. If you wish to re-subscribe in the future, contact a club officer directly.

You may also opt out by contacting a club officer in person or by email (see Section 7 below).

6. HOW TO GET HELP (HELP)

If you need assistance or have questions about the SMS program, reply HELP to any message you receive from us.
